PROGRAM: Las Mañanitas offers a 2 day (Th/F), 3 day (MTW), and 5 day (MTWThF) Morning Program from 8:50am to 12:50pm (organic vegetarian snack and hot lunch included) and a 2 day (Th/F), 3 day (MTW), and 5 day (MTWThF) Afternoon Program from 1pm-4pm (organic hot vegetarian snack included). Each program has a community of 12 children and 3 teachers. Students do not have to be enrolled in the Morning Program to participate in the Afternoon Program. Students in the Morning Programs are welcome to participate in the Afternoon Program in addition to the Morning Program. Our school year begins August 12, 2024 and ends May 30, 2025. We also hold an optional Summer Program from June 2, 2025 through June 20, 2025.

TUITION: Yearly tuition for the 2 day Morning Program is \$6540. Yearly tuition for the 3 day Morning Program is \$9940. Yearly tuition for the 5 day Morning Program is \$16480. Yearly tuition for the 2 day Afternoon Program is \$5560. Yearly tuition for the 3 day Afternoon Program is \$8360. Yearly tuition for the 5 day Afternoon Program is \$13920. For convenience, the yearly tuition is divided into ten monthly installments. Payment is due on the first day of each month beginning in August. Limited need based scholarships are available. Please see the Scholarship Application to view the income criteria. Scholarship applications will be processed through FAST (Independent School Management). Families who indicate an interest in applying for a scholarship will receive a link to FAST. Preschool For All funds may also be available for families who meet PSFA criteria (a child who turns 4 before December 1, 2024, is enrolled in the 3 or 5 day Morning Program, and who has proof of SF residency). Las Mañanitas also accepts SF Early Learning Scholarship Vouchers and CALWORKs Vouchers.

HOLIDAYS: Las Mañanitas follows the SFUSD academic calendar. A complete and final list of the observed holidays, professional development days, and vacations will be provided in May 2024.

APPLICATION PROCESS: Children who are 2 years 5 months by September 1, 2024 are eligible to apply. We will also be including kinder age eligible along with our current TK students into our school community. We try to balance our program by age, gender, and level of Spanish proficiency to the best of our ability.
